CONTRACT AGREEMENT NO. 2024-22

THIS AGREEMENT made the <u>day of jul 29 and</u> 2024 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator ARNALDO A. IGNACIO of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and XITRIX COMPUTER CORPORATION represented by its Account Manager, Mr. MARLOU B. LIBAO of #23 Detroit St., cor. Egea, Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees</u> that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- In consideration for the sum of Six Million One Hundred Eighty-eight Thousand Pesos (Php6,188,000.00) or such other sums as may be ascertained, XITRIX COMPUTER CORPORATION agrees to Bidding for the Supply and Delivery of Various ICT Equipment – Lot 1 in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


