

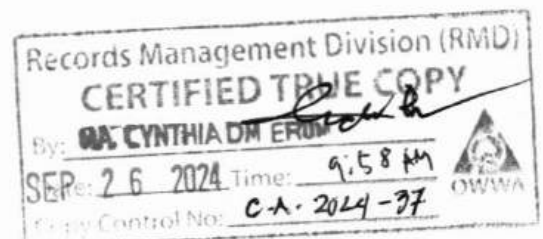
## CONTRACT AGREEMENT NO. 2024-27

THIS AGREEMENT made the \_\_\_\_\_ day of SEP 25 2024 2024 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **MYBUSYBEE, INC.** represented by its **Chief Executive Officer, Mr. RICO M. HERNANDEZ** of Unit 7 G/F Burgundy Place Condominium, 174-B Gonzales St., Loyola Heights, Quezon City (hereinafter called "the Supplier") of the other part;

  - (d) Notice of Award of Contract and the Bidder's conforme thereto;
  - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Three Hundred Eighty-four Thousand Pesos (Php384,000.00)** or such other sums as may be ascertained, **MYBUSYBEE, INC.** agrees to **One (1) Lot – Supply and Delivery of SMS Gateway** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
