

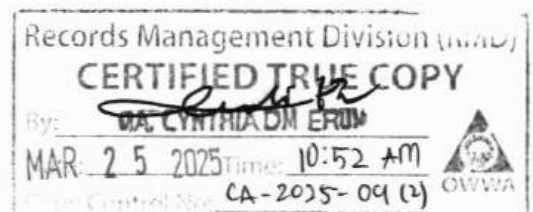
CONTRACT AGREEMENT NO. 2025-11

THIS AGREEMENT made the ____ day of MAR 21 2025 20__ between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **PEOPLE DYNAMICS, INC.** represented by its **HR Solutions Director, Ms. JANINA ROSE Q. 

 - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned.
3. In consideration for the sum of **Five Hundred Thousand Pesos (Php500,000.00)** or such other sums as may be ascertained, **PEOPLE DYNAMICS, INC.** agrees to **Proposal for the Purchase of 2,000 meters Online Assessment for One (1) Year** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


