

CONTRACT AGREEMENT NO. 2025-17

THIS AGREEMENT made the 16th day of JULY 2025 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ATTY. PATRICIA YVONNE M. CAUNAN** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **ANSIBLE TECHNOLOGIES CORP.** represented by its **Engineering Head, Mr. BENJAMIN ESGUERRA** of B31 L20 Bamberg St., Mercedez Business Park, Mercedez Ave., Cainta, Rizal (hereinafter called "the Supplier") of the other part;



 - (e) Other contract documents that may be required by existing laws and/or the Entity.

In consideration for the sum of **Four Hundred Fifty-Three Thousand Six Hundred Pesos (Php453,600.00)** or such other sums as may be ascertained, **ANSIBLE TECHNOLOGIES CORP.** agrees to **Proposal for One (1) Lot – Straight Lease of Managed Communication Equipment (PABX System) for Ten (10) Months** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


