

CONTRACT AGREEMENT NO. 2025-03

THIS AGREEMENT made the 27 JAN 2025 day of 20 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **PLDT INC.** represented by its **Vice President and Center Head of Enterprise Strategic Solutions, Ms. RUBY S. MONTOYA** of Ramon Cojuangco Building, Makati Avenue, Makati City (hereinafter called "the Supplier") of the other part;




NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned.
3. In consideration for the sum of **Five Hundred Thousand Pesos (Php500,000.00)** or such other sums as may be ascertained, **PLDT INC.** agrees to **Proposal for One (1) Lot – Subscription of 30 SIP Trunks for OWWA Hotline 1348** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
