

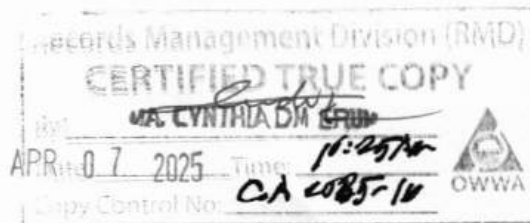
CONTRACT AGREEMENT NO. 2025-06

THIS AGREEMENT made the 04 APR 2025 day of 20 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator ARNALDO A. IGNACIO** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **MANILA BULLETIN PUBLISHING CORPORATION** represented by its **Head of Advertising Sales, Ms. SHELA G. SARMIENTO** of Muralla St. Cor. Recoletos St. Intramuros, Manila (hereinafter called "the Supplier") of the other part;



 - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned.

In consideration for the sum of **Three Hundred Seven Thousand Seven Hundred Twenty-two Pesos and 24/100 (Php307,722.24)** or such other sums as may be ascertained, **MANILA BULLETIN PUBLISHING CORPORATION** agrees to **Proposal for One (1) Lot - Broadsheet Placement Advertisements for the Various Socio-Cultural Events and Significant Milestones of OWWA** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
