

Contract Agreement No. 2020-01

THIS AGREEMENT made this ~~_____~~ ^{FEB 16} day of ~~_____~~ ²⁰²⁰ 2020 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its **Administrator HANS LEO J. CACDAC**, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **LIFEGUARD GABRIEL SECURITY AGENCY CORPORATION** represented by its **President and General Manager, Mr. ROCINIAN G. GECOSALA**, of Unit 2-1 Maxsalome Condominium, 457 Barangka Drive, Mandaluyong City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invite Bids for the provision of **Bidding for the Provision of Security Services for the OWWA Central Office for CY 2020** as specified in the Technical Specifications attached herewith in this contract and has accepted a Bid by the Supplier for the sum of **Twenty One Million Four Hundred Eighty Seven Thousand Eight Hundred Two Pesos and 28/100 (Php21,487,802.28)** hereinafter called the "**Contract Price**".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


