THIS AGREEMENT made this ___ day of ____ 2020 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), represented by its Administrator HANS LEO J. CACDAC, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "Entity" of the one part and NISSAN COMMONWEALTH, INC. represented by Authorized Representative, Mr. BRYAN DAVID TOMAS, of 41 Commonwealth Avenue, Brgy. Holy Spirit, Quezon City hereinafter called the "Supplier" of the other part.

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
