

Contract Agreement No. 2020-04

THIS AGREEMENT made this ___ day of FEB 17 2020 2020 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its **Administrator HANS LEO J. CACDAC**, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **DBP SERVICE CORPORATION** represented by its **Executive Vice President, RAUL LUIS D. MANALIGOD**, of 2nd Floor Executive Building Centre, Sen. Gil Puyat Ave. corner Makati Avenue, Makati City hereinafter called the "**Supplier**" of the other part.


WHEREAS, the Entity invited Bids for the provision of **Rebidding for the Provision of One (1) Lot - Janitorial (Including Supplies) and Other Support Services for OWWA Central Office for CY 2020** as specified in the Technical Specifications and has accepted a Bid by the Supplier in the sum of **Thirty Nine Million Five Hundred Seventy Three Thousand Ten Pesos and 98/100 (Php39,573,010.98)** hereinafter called the "**Contract Price**".


NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the
