This AGREEMENT made this 05 JUN 2020 day of QUEZON CITY between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC**, OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**FIRST PARTY**" of the one part and **H-ASIA NEWSPAPERS & MAGAZINES, INC.** represented by its **President HONESTO Y. VILLANUEVA**, Lot 3 F-4 Omega Avenue, West Fairview Park Subd., Fairview 2, Quezon City hereinafter called the "**SECOND PARTY**" of the other part:




NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and constructed as part of this Agreement, viz.:
 - (a) Terms of Reference;
 - (b) Request for Quotation/Proposal;
 - (c) Abstract of Price Quotation;
 - (d) Bidders eligibility documents;
 - (e) Notice of Award of Contract and the Bidder's conforme thereto;
 - (f) Omnibus Sworn Statement.
3. In consideration of the payments to be made by the **FIRST PARTY** to the **SECOND PARTY** as hereinafter mentioned, the **SECOND PARTY** hereby covenants with the **FIRST PARTY** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **FIRST PARTY** hereby covenants to pay the **SECOND PARTY** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


