

## Contract Agreement No. 2020-06

THIS AGREEMENT made this \_\_\_ day of JUN 30 2020 <sup>SAN JUAN, MM</sup> 2020 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its **Administrator HANS LEO J. CACDAC**, of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **INTEGRATED COMPUTER SYSTEMS, INC.** represented by its **Account Executive, EDEN R. BAUTISTA**, of 3/F Limketkai Bldg., Ortigas Ave., Greenhills, San Juan City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invited Bids for the provision of **Re-bidding for the Supply and Delivery of Various Consumables for 4<sup>th</sup> Quarter for CY 2019 (Lot 1- Canon and Epson Brands)** as specified in the Technical Specifications and has accepted a Bid by the Supplier in the sum of **Four Hundred Ninety-One Thousand Seven Hundred Seventy-Five Pesos (Php491,775.00)** hereinafter called the "**Contract Price**".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
