

Contract Agreement No. 2020-07

THIS AGREEMENT made this 26 day of JUN 26 2020 2020 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its Administrator **HANS LEO J. CACDAC**, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **ACCESSORIES AND SUPPLIES DEPOT, INC.** represented by its In-House Sales, **KYRA D. EBOJO**, of 110 Labo St., Barangay Salvacion, Quezon City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invited Bids for the provision of **Re-bidding for the Supply and Delivery of Various Consumables for 4th Quarter for CY 2019 (Lot 2 – HP Brand)** as specified in the Technical Specifications and has accepted a Bid by the Supplier in the sum of **Seven Hundred Eighty-Four Thousand Eight Hundred Twenty-Five Pesos (Php784,825.00)** hereinafter called the "**Contract Price**".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (g) the Abstract of Bids as Calculated and Eligibility and Technical Check Form (Annex "G");
 - (h) the Entity's Notification of Award (Annex "H");
 - (i) the Performance Security (Annex "I");
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
