

Contract Agreement No. 2020-08

This AGREEMENT made this JUL 01 2020 day of _____ between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC**, OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Client**" of the one part and **JMC PEST MANAGEMENT** represented by its **Proprietor/Owner CAESAR M. TADIARCA**, 30-A Mariveles St., Sta. Mesa Heights, Quezon City hereinafter called the "**Contractor**" of the other part.

3. In consideration of the payments to be made by the Client to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Client to execute and complete the Services and remedy any defects therein in conformity with the provisions of this Contractor in all respects.
4. The Client hereby covenants to pay the Contractor in consideration of the execution and completion of the Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
