

CONTRACT AGREEMENT NO. 2021-11

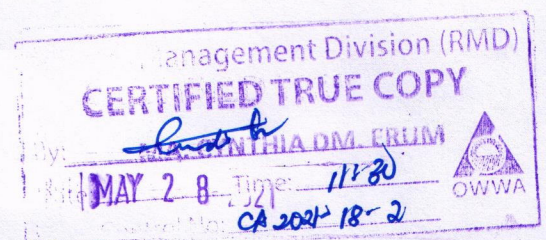

THIS AGREEMENT made the _____ day of _____ 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **GMO GLOBALSIGN, INC.** represented by its Sales, Lead Team **Ms. KIMBERLY S.  - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Seventy One Thousand Four Hundred Three Pesos and 36/100 (Php71,403.36)** or such other sums as may be ascertained **GMO GLOBALSIGN, INC.** agrees to **Proposal for the Supply and Delivery of Secure Socket Layer (SSL)** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






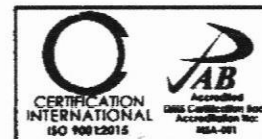
