

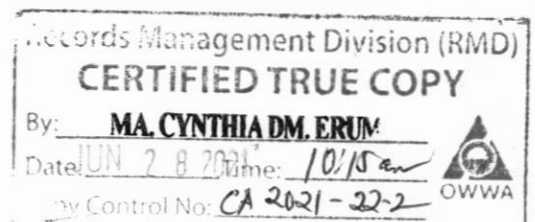
CONTRACT AGREEMENT NO. 2021-12

THIS AGREEMENT made the day of JUN 01 2021 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **SKY BIZ (SKY CABLE CORPORATION)** represented by its SKYBIZ Business Unit Head **Mr. RODERICK U. LIWANAG** of 6F ELJ Communication Center, Eugenio Lopez Drive, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Proposal for One (1) Lot - Subscription of Cable Television for Eight (8) Outlets at OWWA Center Building for One (1) Year Subscription for CY 2021** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Fifty Four Thousand Pesos (Php54,000.00)** (hereinafter called "the Contract Price").

 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Fifty Four Thousand Pesos (Php54,000.00)** or such other sums as may be ascertained, **SKY BIZ (SKY CABLE CORPORATION)** agrees to **Proposal for One (1) Lot - Subscription of Cable Television for Eight (8) Outlets at OWWA Center Building for One (1) Year Subscription for CY 2021** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


