

CONTRACT AGREEMENT NO. 2021-14

THIS AGREEMENT made the _____ day ^{JAN 30 2021} 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **THE BRAIN COMPUTER CORPORATION** represented by its **Account Executive DIANTE BARROZO** of TBCC Bldg., No. 150 F. Blumentritt St. Brgy. Batis, San Juan City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Rental of Four (4) units Desktop Computer** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Thousand Pesos (Php100,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - (a) Purchase Request;
 - (b) Request for Price Quotation;
 - (c) Bid proposal, Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **One Hundred Thousand Pesos (Php100,000.00)** or such other sums as may be ascertained, **THE BRAIN COMPUTER CORPORATION** agrees to **Rental of Four (4) units Desktop Computer** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. In case of failure to deliver the goods and services within the prescribed schedule, the OWWA shall enforce the penalty of one-tenth (1/10) of one percent for every day of delay on the undelivered portion(s) and/or shall apply Section 68 of the 2016 of the Revised Implementing Rules and Regulations of Republic Act 9184 for liquidated damages.

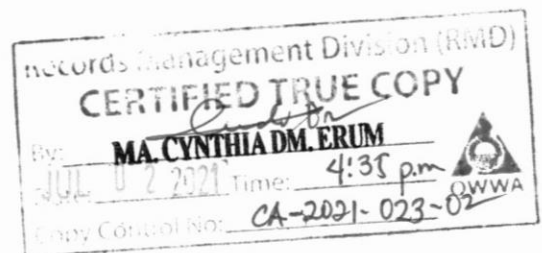
