
CONTRACT AGREEMENT NO. 2021-14

- In consideration for the sum of One Hundred Thousand Pesos
 (Php100,000.00) or such other sums as may be ascertained, THE BRAIN
 COMPUTER CORPORATION agrees to Rental of Four (4) units Desktop
 Computer in accordance with his/her/its Bid.
- The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)
 agrees to pay the above-mentioned sum in accordance with the terms of the
 Bidding.
- 5. In case of failure to deliver the goods and services within the prescribed schedule, the OWWA shall enforce the penalty of one-tenth (1/10) of one percent for every day of delay on the undelivered portion(s) and/or shall apply Section 68 of the 2016 of the Revised Implementing Rules and Regulations of Republic Act 9184 for liquidated damages.


