

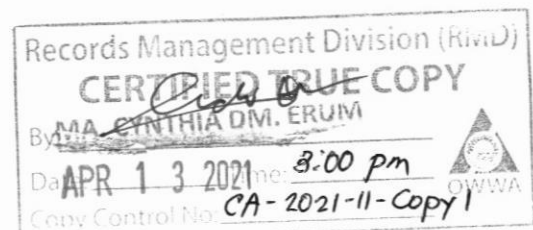
CONTRACT AGREEMENT NO. 2021-04

THIS AGREEMENT made the \_\_\_\_\_ day of MAR 23 2021 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC** of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **PISHON INDUSTRIES, INC.** represented by its **President/General Manager MYLEEN L. BUMANGLAG** of No. 32 Bicameral Rd Violago Subd. Batasan Hills, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **One (1) Lot - Supply and Delivery of Purified Drinking Water for the period of ten (10) months from March to December 2021** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Twenty Five Thousand Pesos (Php425,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - (a) Terms of Reference;
  - (b) Request for Price Quotation;
  - (c) Eligibility requirements, documents and/or statements;
  - (d) Notice of Award of Contract and the Bidder's conforme thereto;
  - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Four Hundred Twenty Five Thousand Pesos (Php425,000.00)** or such other sums as may be ascertained, **PISHON INDUSTRIES, INC.** agrees to **One (1) Lot - Supply and Delivery of Purified Drinking Water for the period of ten (10) months from March to December 2021** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

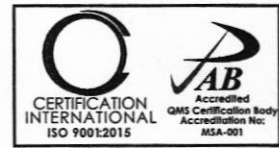
