

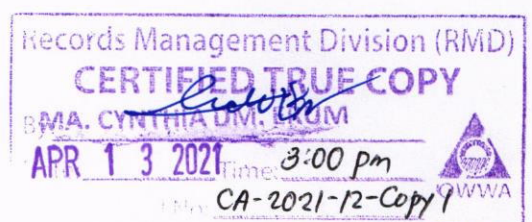
CONTRACT AGREEMENT NO. 2021-05

THIS AGREEMENT made the MAR 22 2021 day of _____ 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **JMC PEST MANAGEMENT** represented by its **Proprietor/Owner CAESAR M. TADIARCA** of 30-A Mariveles St. Brgy. Sta. Teresita, Quezon City (hereinafter called "the Supplier") of the other part;




 - (a) Terms of Reference;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **One Hundred Twelve Thousand Pesos (Php112,000.00)** or such other sums as may be ascertained, **JMC PEST MANAGEMENT** agrees to the **Supply of Labor and Materials for the application of Pest Control weekly from March 2021 to December 2021** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


