

CONTRACT AGREEMENT NO. 2021-08

THIS AGREEMENT made the _____ day of 13 APR 2021 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **CONVERGE ICT SOLUTIONS, INC.** represented by its **Key Account Manager PRINCESS JOSEFA MARCELO** of Reliance Center Annex 1, 99 E. Rodriguez Jr. Ave., Bo. Ugong, Pasig City (hereinafter called "the Supplier") of the other part;

 - (e) Other contract documents that may be required by existing laws and/or the Entity.

In consideration for the sum of **Two Hundred Eight Thousand Six Hundred Fifty Six Pesos (Php208,656.00)** or such other sums as may be ascertained, **CONVERGE ICT SOLUTIONS, INC.** agrees to **One (1) Lot – Provision of 10 Mbps Dedicated Internet Connection Services to the OWWA-MPC POEA, Mandaluyong City** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

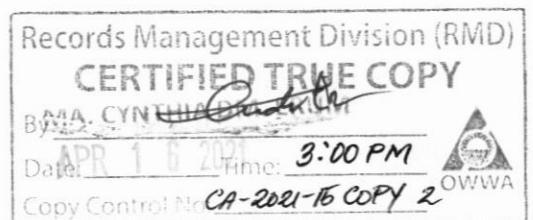

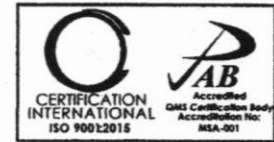
