

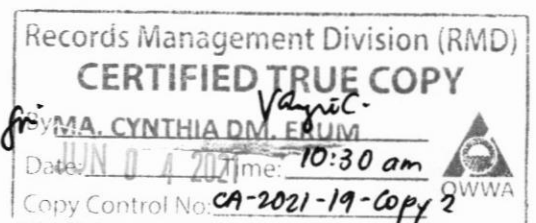
CONTRACT AGREEMENT NO. 2021-09

THIS AGREEMENT made the _____ day of JUN 02 2021 2021 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC** of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and **CENTILE PSYCHOLOGICAL ASSESSMENTS** represented by its Registered Psychologist **Mr. VICENTE V. PANGANIBAN** of Room 505 Dona Amparo Bldg., Espana cor. Tolentino St., Sampaloc, Manila (hereinafter called "the Supplier") of the other part;



 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration for the sum of **Two Hundred Thousand Pesos (Php200,000.00)** or such other sums as may be ascertained, **CENTILE PSYCHOLOGICAL ASSESSMENTS** agrees to **Proposal for the Purchase of 2,000 meters Online Assessment** in accordance with his/her/its Bid.
4. The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

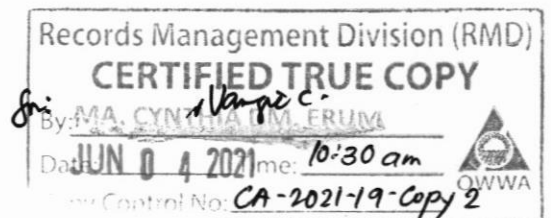




