
CONTRACT AGREEMENT NO. 2021-09

THIS AGREEMENT made the ______ day of JUN 0 2 2021 2021 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) represented by its Administrator HANS LEO J. CACDAC of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines (hereinafter called "the Entity") of the one part and CENTILE PSYCHOLOGICAL ASSESSMENTS represented by its Registered Psychologist Mr. VICENTE V. - The OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




