



## Contract Agreement No. 2015-09

THIS AGREEMENT made this DEC 29 2015 day of 2015 between **OVERSEAS WORKERS WELFARE ADMINISTRATION** of OWWA Center cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines hereinafter called the "**Entity**" of the one part and **DBP SERVICE CORPORATION** of Makati City, Philippines hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invited Bids for the provision of **2016 JANITORIAL (Including Supplies) AND SUPPORT SERVICES** for **ONE YEAR** from **JANUARY 1, 2016 to DECEMBER 31, 2016** and has accepted a Bid by the Supplier for the sum of **Twenty Eight Million Three Hundred Eighty Four Thousand One Hundred Sixty Nine Pesos and 34/100 only (Php28,384,169.34)** hereinafter called the "Contract Price".


NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


