THIS AGREEMENT made this ___ day of ______ 2017 between OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), represented by its Administrator HANS LEO J. CACDAC, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "Entity" of the one part and DESIGN EXCELLENCE HOME AND OFFICE SYSTEM CO. represented by its Project Sales Consultant, MARITESS BAQUIRAN, of No. 1 Binmaka St., corner Biak na Bato Brgy. Manresa, Quezon City hereinafter called the "Supplier" of the other part.

WHEREAS, the Entity invite Bids for the provision of One (1) Lot - Supply and Delivery of Folding Tables and Stacking Chairs as specified in the Technical Specifications attached herewith in this contract and has accepted a Bid by the Supplier for the sum of Eight Hundred Fifty Seven Thousand Twenty Five Pesos (Php857,025.00) hereinafter called the "Contract Price".

- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
