

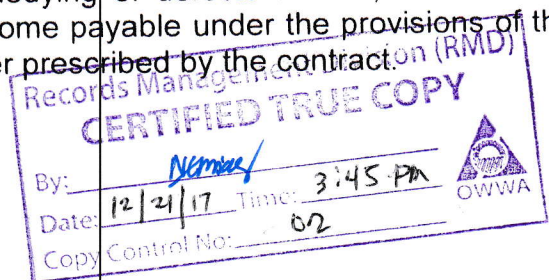
## Contract Agreement No. 2017-10

THIS AGREEMENT made this DEC 21 2017 day of 2017 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its **Administrator HANS LEO J. CACDAC**, of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **WIFICITY INC.** represented by its **Account Manager, JETRO JUDE D. ISIDRO**, of 3902 Discovery Center, 25 ADB Avenue, Ortigas Center, Pasig City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invite Bids for the provision of **Re-Bidding for the Subscription of Internet Leased Line 6Mbps Dedicated Internet Connection On-Line PDOS Portal/PDOS On-Line Program and 10 Mbps for Secondary Internet Source** as specified in the Technical Specifications attached herewith in this contract and has accepted a Bid by the Supplier for the sum of **Four Hundred Twenty Thousand Pesos (Php420,000.00)** hereinafter called the "**Contract Price**".


NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

  - (j) the Performance Security (Annex "J")
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


