

Contract Agreement No. 2017-02

This AGREEMENT made this _____ day of _____ between **OVERSEAS WORKERS WELFARE ADMINISTRATION** of OWWA Center cor. 7th Street and F.B. Harrison Street, Pasay City, Philippines hereinafter called the "Entity" of the one part and **DBP SERVICE CORPORATION** of 2nd Floor Executive Bldg., Center Gil Puyat Avenue, Makati City, Philippines hereinafter called the "Supplier" of the other part.

WHEREAS, the Entity invited Bids for the provision of **Janitorial and Other Support Services for OWWA Central Office CY 2017 for 122 Personnel** and has accepted a Bid by the Supplier for the sum of **Seventeen Million Five Hundred Eleven Three Hundred Eight Pesos and 54/100 (Php17,511,308.54)** for the payment of seven (7) months service from June 01, 2017 to December 31, 2017 and hereinafter called the "Contract Price".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
