


## Contract Agreement No. 2017-09

THIS AGREEMENT made this      day of JAN 26 2018 2017 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its **Administrator HANS LEO J. CACDAC**, of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **MICRODATA SYSTEMS AND MANAGEMENT INC.** represented by its **Account Manager, MARY JANE T. MENDOZA**, of 199 CM Recto cor. A. Mabini, San Juan City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invite Bids for the provision of **Re-Bidding for One (1) Lot - Supply and Delivery of Digital Microfilm Camera and Digital Microfilm Scanner** as specified in the Technical Specifications attached herewith in this contract and has accepted a Bid by the Supplier for the sum of **One Million Seven Hundred Nine Thousand Pesos (Php1,709,000.00)** hereinafter called the "**Contract Price**".


NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




