Harrison St., Pasay City, Philippines, hereinafter called the "Entity" of the one part and SUPER-AIRE REFRIGERATION AND CONTRACTORS, INC. represented by its Sales Executive, REGION PACHES, of 3A St. Francis Street, Brgy. Immaculate, Cubao, Quezon City hereinafter called the "Supplier" of the other part.

- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
