KNOW ALL MEN BY THESE PRESENTS

This Agreement made and entered into by and between the **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, a government agency under the Department of Labor and Employment, with office address at OWWA Center Building, F.B. Harrison Street corner 7th Street, Pasay City, represented herein by its Administrator, **HANS LEO J. CACDAC**, and hereinafter referred to as the "**OWWA**".

JJJ NEWSPAPER & MAGAZINES, a private newspapers/magazines carrier, whose office is located at 35 Visayas Avenue, Vasra, Quezon City, herein called as the **SECOND PARTY**, and represented by its Proprietor, **JORGE P. DIOMAMPO**, hereinafter referred to as the "**CONTRACTOR**".

-WITNESSETH-

WHEREAS, OWWA requires the services of a dependable local newspaper carrier, which shall provide the current events materials that have a direct impact or implications on the concerns of the agency;

WHEREAS, JJJ NEWSPAPER & MAGAZINES is an authorized subscription agent of all local and international newspapers in the Philippines;

WHEREAS, JJJ NEWSPAPER & MAGAZINES is authorized to accept newspaper subscriptions for Abante, Abante Tonite, Balita, Bulgar, People's Journal, People's Tonight, Pilipino Star Ngayon, Tempo, (Business Insight) Malaya, Manila Bulletin, Manila Standard Today, Manila Times, Philippine Daily Inquirer, Philippine Star, Daily Tribune, Bandera and Business Mirror;

NOW, THEREFORE, the parties hereto agree as follows:

THAT in any event that the local newspaper are not delivered to the place herein stated or mentioned, corresponding replacement will be accordingly made or subscriptions be extended equivalent to the undelivered portion;

THAT the processing period of the local newspapers are as follows:

Abante, Abante Tonite, Balita, Bulgar, People's Journal, People's Tonight, Pilipino Star Ngayon, Tempo, (Business Insight) Malaya, Manila Bulletin, Manila Standard Today, Manila Times, Philippine Daily Inquirer, Philippine Star, Daily Tribune, Bandera and Business Mirror shall be delivered on a daily basis for ten (10) months;

THAT the number of copies of newspaper to be delivered of which is here to specify in **Annex "A"** as part of the contract;

THAT the **CONTRACTOR** shall deliver before 5:30 AM every morning (Saturday, Sunday including Public Holidays);

THAT, OWWA shall pay the **CONTRACTOR** the sum of **Two Hundred One Thousand Eight Hundred Sixty Nine Pesos and 20/100 (Php201,869.20)** for the delivery of the above-mentioned local newspapers from March to December 2017;

THAT, OWWA shall pay the **CONTRACTOR** on a monthly basis 15 days upon receipt of Statement of Account;

THAT, OWWA shall pay the CONTRACTOR in advance the sum of **Thirteen Thousand Four Hundred Fifty Pesos (Php13,450.00)** for 52 issues (March to December 2017) of The Economist Magazine;

THAT, OWWA shall pay any price increase that may be incurred during the year relative to the newspapers upon presentation of proof and effectivity;


THAT, in case of failure of the CONTRACTOR to perform any part of the Agreement, OWWA shall have exercise its right to rescind this agreement and to demand a cash refund equivalent to the payment made for the undelivered portion of the local newspapers;

THAT, this Agreement shall take effect for a period of ten (10) months to commence on March 2017 to December 2017.

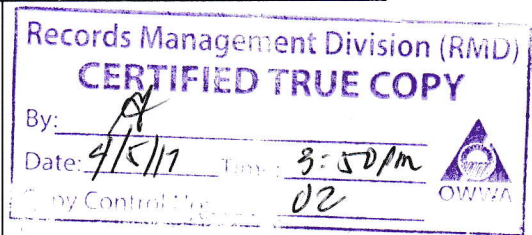
