

## Contract Agreement No. 2017-01

This AGREEMENT made this JUN 08 2017 day of \_\_\_\_\_ between **OVERSEAS WORKERS WELFARE ADMINISTRATION** of the Philippines (hereinafter called "the Entity") of the one part and **LIFEGUARD ARCHANGELS SECURITY AGENCY CORPORATION** of Makati City, Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for the provision of "**Security Services for Sixty Five (65) Personnel for Three (3) years**" and has accepted a Bid by the Supplier for the sum of **Ten Million Five Hundred Seventeen Thousand Four Hundred Twenty Nine Pesos and 02/100 (Php10,517,429.02)** for the payment of seven (7) months service from June 01, 2017 to December 31, 2017 and hereinafter called "the Contract Price".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in all respects in conformity with the provisions of the Contract.
4. In consideration of the provision of the services and the remedying of defects therein, the Entity hereby covenants to pay the Supplier the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in time manner prescribed by the contract.

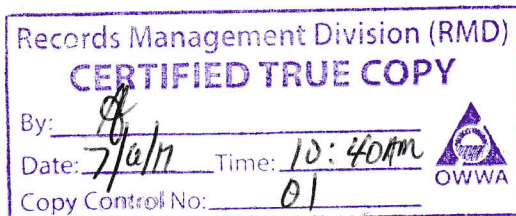
