## Contract Agreement No. 2017-01

This AGREEMENT made this \_\_\_\_\_\_\_\_ between OVERSEAS WORKERS WELFARE ADMINISTRATION of the Philippines (hereinafter called "the Entity") of the one part and LIFEGUARD ARCHANGELS SECURITY AGENCY CORPORATION of Makati City, Philippines (hereinafter called "the Supplier") of the other part:

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 4. In consideration of the provision of the services and the remedying of defects therein, the Entity hereby covenants to pay the Supplier the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in time manner prescribed by the contract.
