

SERVICE CONTRACT

KNOWN ALL MEN BY THESE PRESENTS:

This Contract entered into by and between:

The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, a government entity with office address at OWWA Center, located at the 7th corner F.B. Harrison Sts., Pasay City, Metro Manila, represented by Administrator HANS LEO J. CACDAC, and hereinafter referred to as "OWWA".

RADIO VERITAS GLOBAL BROADCASTING SYSTEM, INC. (RVGBSI), represented by its President REV. FR. ANTONIO CECILIO T. PASCUAL, aired over the facilities of radio station - Veritas 846, with office address located at Paramount Building, 162 West Avenue corner EDSA Quezon City, referred to as "CONTRACTOR".

WITNESSETH

WHEREAS, OWWA is a government agency tasked with the twin mandate to ensure the viability of the Fund and to provide welfare services to the Overseas Filipino Workers;

WHEREAS, OWWA deems it is necessary to launch and intensify information campaign to reeducate the public on the status of the agency, its programs, services, achievements and related information;

WHEREAS, OWWA accepts the services of RVGBSI for its information drive by way of radio plugging, ad placements to ensure effective and responsive delivery of programs and services to its publics;


WHEREAS, OWWA shall provide necessary information and materials needed for the radio airings through the Advocacy and Social Marketing Division (ASMD);

WHEREAS, RVGBSI shall ensure OWWA a main billing in Two (2) 30-second radio plugging daily (Mon-Fri) to be aired for three (3) months starting May 1 up to July 31, 2018 plus 30-minute interview once a month at Good Samaritan program between 1-3pm.

WHEREAS, RVGBSI shall ensure airing and coverage of OWWA concerns by the host's news and production team.

WHEREAS, RVGBSI shall assist in the production of OWWA radio plugs needed for its monthly airing of ads.

WHEREAS, In the event OWWA needs to air to other provincial Radio Stations, RVGBSI is willing to assist OWWA thru other provincial Radio Stations directly related to Veritas 846 for a fee.

WHEREAS, RVGBSI shall provide the following media values:

- Program Sponsorship of Veritas Balita aired from Monday – Friday at 5:30AM with one (1) 30-seconder spot, with OBB/CBB and tagline
- Two 30-seconder spots between 8AM-5PM Monday - Friday
- Two time checks with tagline between 4PM-9:30PM, Monday – Friday
- 30-minute interview once a month at Good Samaritan Program between 1-3PM, Mon-Fri
- Announcement of OWWA's activities and other promotions if any
- Logo inclusion with link at Radio Veritas website, www.veritas846.ph
- Logo inclusion in 1/2 page full color newspaper ads at Manila Bulletin

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

THAT, this contract shall take effect from May 01, 2018 up to July 31, 2018 and maybe renewed by mutual agreement of both parties unless the same is earlier terminated by either party on grounds of violations of any of the terms and conditions hereof, that the contract termination shall take effect at least thirty (30) days after a written notice is given;

THAT, OWWA agrees to pay RVGBSI in respect of the said services the sum of SIXTY-FIVE THOUSAND PESOS (P65,000.00) VAT inclusive a month effective May 01, 2018 up to July 31, 2017 for the delivery of services as promised and stipulated above. Processing of voucher shall only commence after the Bill of Account, Certificate of Broadcast, Certificate of Performance by the CONTRACTOR and CD copy of the Proof of Airing are submitted.

THAT, in case of failure of RVGBSI to fulfill any part of the agreement without justifiable reason, OWWA shall exercise the option to rescind the agreement by giving a written notice to take effect Thirty (30) days after receipt thereof.

THAT, this Service Contract shall commence and take effect starting May 01, 2018 and shall remain in effect until December 31, 2018 with the option to renew/extend subject to the budget availability.




