

Contract Agreement No. 2018-02

THIS AGREEMENT made this 06 day of 2018 2018 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its **Administrator HANS LEO J. CACDAC**, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **DBP SERVICE CORPORATION** represented by its **Vice President for Marketing, GERRY A.C. ARELLANO**, of 2nd Floor Executive Building Centre, Sen. Gil Puyat Ave. corner Makati Avenue, Makati City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invite Bids for the provision of **Re-Bidding for One (1) Lot - Provision of Janitorial (Including Supplies) and Other Support Services but not limited to Data Encoders, Maintenance Personnel, Drivers and Telephone Operators for the OWWA Central Office for CY 2018 for One Hundred Twenty Two (122) Personnel** as specified in the Technical Specifications attached herewith in this contract and has accepted a Bid by the Supplier for the sum of **Ten Million Three Hundred Ninety Six Thousand Pesos and 53/100 (Php10,396,000.53)** hereinafter called the "**Contract Price**".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (g) the Abstract of Bids as Calculated and Eligibility and Technical Check Form (Annex "G");

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
