

## Contract Agreement No. 2019-05

THIS AGREEMENT made this \_\_\_\_ day of JUN 25 2019 2019 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its **Administrator HANS LEO J. CACDAC**, of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **MZR BUILDERS** represented by **VP Marketing & Finance, Ms. MARILOU R. QUIROZ**, of 32 Chicago St., Brgy. Pinagkaisahan, Cubao, Quezon City hereinafter called the "**Supplier**" of the other part.


WHEREAS, the Entity invited Bids for the **Bidding for One (1) Lot – Supply and Installation of PVC Laminated Gypsum Ceiling Board** as specified in the Technical Specifications and has accepted a Bid by the **Supplier** for the sum of **Three Million One Hundred Eleven Thousand Seven Hundred Thirty One Pesos (Php3,111,731.00)** hereinafter called the "**Contract Price**".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (g) the Abstract of Bids as Calculated and Eligibility and Technical Check Form (Annex "G");
  - (h) the Entity's Notification of Award (Annex "H");
  - (i) the Performance Security (Annex "I");
3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
