

Contract Agreement

This AGREEMENT made this _____ day of _____ between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its Administrator **HANS LEO J. CACDAC**, OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **RPCORSINO CADD CAMP AND CONSTRUCTION** represented by its President **REUEL P. CORSINO**, Unit 310 J & F Divino Arcade, 961 Aurora Blvd., Brgy. Quirino 3-A, Quezon City hereinafter called the "**Consultant**" of the other part.



WHEREAS, the Entity invited Bids for **One (1) Lot - Consultancy Service for Preparation of Design, Plans, Drawings and Detailed Estimates for Renovation of Various Comfort Rooms in the OWWA Center Building** hereinafter called the "Works" and the Entity has accepted the bid for **Five Hundred Thousand Pesos (Php500,000.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and constructed as part of this Agreement, viz.:
 - (a) Terms of Reference;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
