WHEREAS, JJJ NEWSPAPERS & MAGAZINES is authorized to accept newspaper subscriptions for Philippine Daily Inquirer, Philippine Star, Manila Bulletin, Manila Standard, Manila Times, Malaya, Daily Tribune, Business Mirror, Abante, Abante Tonite, Bulgar, Balita, Tempo, People's Tonight, People's Journal, Pilipino Star Ngayon and Bandera;

NOW, THEREFORE, the parties hereto agree as follows:


THAT in any event that the local newspaper are not delivered to the place herein stated or mentioned, corresponding replacement will be accordingly made or subscriptions be extended equivalent to the undelivered portion;

THAT the CONTRACTOR shall deliver before 5:30 A.M. every morning (Saturdays; Sunday including Public Holidays);

THAT, OWWA shall pay the CONTRACTOR fifteen (15) days upon receipt of Statement of Account together with the original delivery receipt;

THAT, OWWA shall pay any price increase that may be incurred during the year relative to the newspapers upon presentation of proof and effectivity;

THAT, in case of failure of the CONTRACTOR to perform any part of the Agreement, OWWA shall have exercise its right to rescind this agreement and to demand a cash refund equivalent to the payment made for the undelivered portion of the local newspapers;


