

Contract Agreement No. 2019-08

THIS AGREEMENT made this ____ day of _____ 2019 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its **Administrator HANS LEO J. CACDAC**, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **UP-TOWN INDUSTRIAL SALES, INC.** represented by **Manager, Indent & Forward Sales Division, Ms. DAISY M. VILLAFUERTE**, of Up-Town Bldg., 56-58 Madison St., 1554 Mandaluyong City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invited Bids for the **Bidding for Supply and Delivery of Various Electrical and Construction Materials** as specified in the Technical Specifications and has accepted a Bid by the **Supplier** for the sum of **One Million Twenty Three Thousand Two Hundred Seventy Nine Pesos and 50/100 (Php1,023,279.50)** hereinafter called the "**Contract Price**".


NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




