

Contract Agreement No. 2019-09

THIS AGREEMENT made this ____ day of SEP 04 2019 2019 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its Administrator **HANS LEO J. CACDAC**, of OWWA Center Building cor. 7th Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **TEKZONE COMPUTER SALES AND SERVICES INC.** represented by Account Manager, **Ms. GLENDA F. BIBIT**, of 32 Pilar St. corner Araullo St. Brgy. Addition Hills, San Juan City hereinafter called the "**Supplier**" of the other part.


WHEREAS, the Entity invited Bids for the **Bidding for the Supply and Delivery of Various Information and Communication Technology (ICT) Equipment for Lot 1 – Central Office** as specified in the Technical Specifications and has accepted a Bid by the **Supplier** for the sum of **Three Million One Hundred Twenty Four Thousand Six Hundred Thirty Nine Pesos (Php3,124,639.00)** hereinafter called the "**Contract Price**".

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:

 - (f) the Supplemental Bid Bulletin No. 1 (Annex "F");
 - (g) the Abstract of Bids as Calculated and Eligibility and Technical Check Form (Annex "G");
 - (h) the Entity's Notification of Award (Annex "H");
 - (i) the Performance Security (Annex "I");
3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
