

**Contract Agreement No. 2019-11**

THIS AGREEMENT made this \_\_\_\_ day of 06 SEP 2019 2019 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, represented by its Administrator **HANS LEO J. CACDAC**, of OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **NTT DATA PHILIPPINES, INC.** represented by **President and CEO, Mr. POCHOLO S. REYES**, of 88 Corporate Center Cedenor cor. Valero Sts., Salcedo Village, Makati City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invited Bids for the **Bidding for One (1) Lot – Supply and Delivery of OWWA Virtual Machine and Cloud Computing Subscription** as specified in the Technical Specifications and has accepted a Bid by the Supplier for the sum of **Two Million Nine Hundred Forty Five Thousand Seven Hundred Fifty Seven Pesos and 29/100 (Php2,945,757.29)** hereinafter called the "**Contract Price**".


NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

  - (f) the Abstract of Bids as Calculated and Eligibility and Technical Check Form (Annex "F");
  - (g) the Entity's Notification of Award (Annex "G");
  - (h) the Performance Security (Annex "H");
3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


