

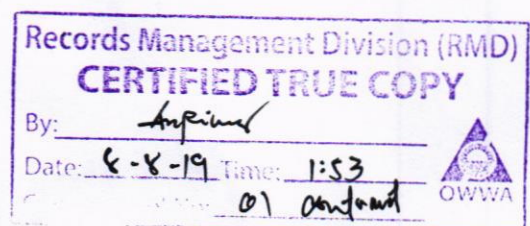
Contract Agreement

This AGREEMENT made this _____ day of _____ between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Deputy Administrator VIVIAN F. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **GMO GLOBALSIGN, INC.** represented by its **Senior Sales Specialist, KIMBERLY SORIANO**, 23F Zuellig Building Paseo De Roxas, Makati Avenue, Makati City hereinafter called the "**Supplier**" of the other part.

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and constructed as part of this Agreement, viz.:
 - (a) Technical Specifications;
 - (b) Request for Price Quotation;
 - (c) Eligibility requirements, documents and/or statements;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Supplier in all respects.
4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Works, the Contract Price or such other sum as such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


