

## Contract Agreement

This AGREEMENT made this 16 day of AUG 2019 between **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)** represented by its **Administrator HANS LEO J. CACDAC**, OWWA Center Building cor. 7<sup>th</sup> Street and F.B. Harrison St., Pasay City, Philippines, hereinafter called the "**Entity**" of the one part and **DIGITAL NETWORK COMMUNICATIONS & COMPUTERS INC. (DIGICOM)** represented by its **Channel Marketing Specialist, MARIETTA AUSTRIA**, 30<sup>th</sup> Flr. Antel Global Corporate Center, Julia Vargas Ave., Ortigas Center Pasig City hereinafter called the "**Supplier**" of the other part.

WHEREAS, the Entity invited Bids for **One (1) Lot – Supply and Delivery of Endpoint Security System** hereinafter called the "Works" and the Entity has accepted the bid for **Seven Hundred Fifty Thousand Pesos (Php750,000.00)** by the Consultant for the execution and completion of Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and constructed as part of this Agreement, viz.:
  - (a) Terms of Reference;
  - (b) Request for Price Quotation;
  - (c) Eligibility requirements, documents and/or statements;
  - (d) Notice of Award of Contract and the Bidder's conforme thereto;
  - (e) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Supplier in all respects.
4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Works, the Contract Price or such other sum as such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
