KNOWN ALL MEN BY THESE PRESENTS

This Services Agreement entered into by and between:

The **OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA)**, a government entity with office address at OWWA Center, located at 7th Street corner F.B. Harrison St., Pasay, Metro Manila, represented by its Administrator HANS LEO J. CACDAC, and hereinafter referred to as "**OWWA**"

- and -

RADIO VERITAS GLOBAL BROADCASTING SYSTEM, INC. (RVGBSI), represented by its President REV. FR. ANTONIO CECILIO T. PASCUAL, aired over the facilities of Radio Veritas 846 every Monday - Friday, with office address Veritas Tower, #162 West Avenue corner EDSA, Quezon City, referred to as "**CONTRACTOR**"

WITNESSETH:

WHEREAS, OWWA is a national government agency mandated to protect the rights/interest and promote the welfare of the OFWs and their families;

WHEREAS, OWWA deems it necessary to launch and intensify information campaign to reeducate the public on the status of the agency, its programs, services, achievements and related information;

WHEREAS, OWWA accepts the services of the (CONTRACTOR) for its information drive by way of interviews/radio plugging/ad placements to ensure effective and responsive delivery of programs and services to its publics;

WHEREAS, OWWA shall provide necessary information and materials needed for the radio through the Advocacy and Social Marketing Division (ASMD);

WHEREAS, the CONTRACTOR shall ensure OWWA a main billing in two(2) 30-second spot, OBB and CBB with tag line daily to be aired for three months and announcements of OWWA's activities and other promotions.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:


THAT, this Service Agreement shall take effect from August 01, 2019 to October 31, 2019 and renewable by mutual consent of both parties unless the same is earlier terminated by either party on grounds of violations of any of the terms and conditions hereof, that the contract termination shall take effect at least thirty (30) days after a written notice is given;

THAT, OWWA agrees to pay the CONTRACTOR in respect of the said services the sum of **FORTY FIVE THOUSAND PESOS (Php 45,000.00) PER MONTH** inclusive of all applicable taxes for the delivery of the services stipulated above. Processing of voucher shall commence only after Bill of Account, submission of Certificate of Broadcast, Certificate of Performance by the CONTRACTOR and CD copy of the Proof of Airing are submitted.

THAT, in case of failure of the CONTRACTOR to fulfill any part of the agreement without justifiable reason, OWWA shall exercise the option to rescind the agreement by giving a written notice to take effect thirty (30) days after receipt thereof.

THAT, this Service Contract shall commence and take effect upon the signing and shall remain in effect until October 31, 2019 with the option to extend subject to the budget availability.
